If you want to invest for your future, the Healthy Investment Guaranteed Anniversary Bonus Bond might be right for you. You can invest for yourself, your children or grandchildren and get the return and security you are looking for.

You can invest from just £500 up to a maximum of £250,000. Investments can be made in a single name or in joint names with your spouse or partner or your children or grandchildren. The choice is yours as long as they are UK residents.

The modest minimum investment makes it an affordable investment and offers you the opportunity for regular bonuses with valuable capital and growth anniversary guarantees.

Regular bonuses

The amount you invest increases through the regular annual bonuses that are added to your investment. You start to earn bonuses from the day that you invest with us and if you withdraw from your bond part way through a year you will still get a bonus for the time your money has been invested.

Bonus rates can change every year and could, in exceptional circumstances, be nil. They depend on investment performance and other factors.

Guaranteed life cover

A small amount of life cover is included as part of your bond. If you die whilst you have money invested in the bond we guarantee to pay out at least what you invested plus any bonuses that have already been added less any withdrawals you have made of course. This life cover is important, especially for older investors who want to make sure their legacy is protected from investment market volatility. For bonds held in joint names the guaranteed life cover applies to the last remaining bondholder.

Protecting your assets

The Guaranteed Anniversary Bonus Bond is an insurance based investment bond which means that, unlike some other investments, it can be used in an Investment Trust and in Inheritance Tax planning. You should always consider taking professional financial, tax or legal advice if you are thinking about setting up a Trust.

Invest for as long as you want

When you invest in a Healthy Investment Guaranteed Anniversary Bonus Bond you do not have to decide how long you want to invest for, however it should be viewed as a medium to long term investment as it includes early surrender penalties in the first 5 years of the investment. It might not be appropriate for investors who do not have some bank or building society savings they can access instantly.

Guaranteeing a fair return

Every year you can withdraw up to 5% of your initial investment without any penalties and Market Value Reduction and without any immediate tax consequences, something that is really useful if you are looking to take a monthly income from your bond.

On occasion it may be necessary, only when you withdraw all or part of your investment, to apply a Market Value Reduction (MVR). We would do this if, after you have made your investment, there has been a significant fall in the value of the stock market or other investments, to ensure that the amount you receive is fair and reflects the value of the various investments in our Ethical With-profits Fund. A MVR could reduce the amount you receive when you withdraw your money, which means that you could get back less than you have invested, if the withdrawal is not made on one of the guaranteed MVR free anniversaries.

When you withdraw from your bond we might also add a final (terminal) bonus to increase the amount you receive. Terminal bonuses are not guaranteed and the value of a terminal bonus can change at any time. They are designed to ensure that the amount you receive is fair.

Capital and growth guarantees

We guarantee that you can withdraw all or part of your investment, plus all the bonuses that have been added, without any penalty or MVR being applied, on the 10th anniversary of the investment and every 5th anniversary after that.

This means that if you withdraw all of the investment on one of these anniversaries you are guaranteed to have not lost any of your original investment or the bonuses that have been added.

We know that these capital and growth guarantees are valuable to investors.

With-profits that works

The Healthy Investment Guaranteed Anniversary Bonus Bond is a With-profits investment.

The money you invest is invested in our Ethical With-profits Fund. We invest this in a wide range of different assets including stocks and shares, government and corporate bonds, commercial property and bank deposits. The value of these investments can rise and fall. We aim to smooth out these rises and falls so that you are not experiencing the day to day ups and downs of stock and bond markets and provide you with a consistent investment return. You should however be aware that this smoothing will not protect you against long term substantial falls in the value of your investments, which means that you might not in these circumstances be able to get all of your investment back until the next anniversary guarantee.
